IMMA 1000 is a fundraising initiative to support the future of Irish contemporary art. During our nation's centenary; we are re-examining what it means to be Irish and asking ourselves how we want the country to develop in the next 100 years. IMMA 1000 will help ensure that the artist remains at the heart of our society. It will do this by creating a fund to specifically support IMMA's work with Irish artists; supporting artists to live and work in Ireland through bursaries and the IMMA residency programme and supporting artists income through commissions, exhibitions, and purchasing work for the IMMA Collection

IMMA 1000 is a fundraising initiative developed on behalf of IMMA by John Cunningham, Director, Check Risk. John was in the audience for a talk given by IMMA Director Sarah Glennie to a group of Irish business leaders in 2014 and was struck by the critical difficulties she outlined facing artists working in Ireland following the economic crisis. John was compelled to help. Working closely with IMMA he has devised a campaign to raise €250,000 by 2018. These funds will be used to directly support Irish artists and will play a critical role in securing the continued growth and vibrancy of Irish contemporary art and continued creativity and innovation for Irish society.

# Why Now?

Substantial cuts in arts funding since 2008 have had a devastating effect on supports available directly to contemporary artists. Arts organisations such as IMMA have also seen cuts of close to 50% in their government funding resulting in fewer acquisitions for public collections, fewer commissions of new work and reduced artist fees. Overall these combined cuts create an overwhelming reduction in the funding that institutions such as IMMA can use to directly support artists.

The commercial art market in Ireland also faces considerable challenges and as organisations slowly start to rebuild after years of successive cuts it is essential that IMMA is able to actively support Irish artists so that Ireland will remain a viable place for them to live and work into the future. If not, the effect of their loss will be felt for generations to come.

## How you can help

We are asking 1000 individuals to donate €1000 (If you are a PAYE employee a donation of €690 will result in a donation of €1000 for IMMA through tax relief). Each and every donation we receive will bring us closer to our target and provide the vital resources necessary to support this generation of Irish artists.

- Creating new annual bursaries to support Irish artists taking part in IMMA's Artists Residency Programme.
- Commissioning new work as part of IMMA's Exhibitions, Education and Collections programmes.
- Supporting the acquisition of living Irish Artists into the IMMA Collection.
- Exhibiting living Irish artists in IMMA.
- Raising international awareness of Irish art through an invited curators programme and the development of international studio exchanges.
- Creating a unique digital resource of the Irish art represented in IMMA's programme and Collection.
